Protecting Your Practice from Ethical Pitfalls

Practitioners regularly face challenges in their practice due to circumstances that arise after treatment begins. These issues include requests for records, changes in the nature of the services being provided, and changes in roles. This presentation will discuss how these scenarios can arise, and steps practitioners should take to thoroughly address the situations.

Looking at informed consent is an ongoing process very much influenced and dependent upon case formulation, treatment choices and the anticipation of future consequences of these choices. Examining the need to be able to adequately and meaningfully articulate these choices to clients as a continual part of ethical therapeutic collaboration and the potential consequences of not doing so.

Considering themes of recent complaints to the NH Board of Mental Health Practice and the nature of investigations, we will review best practice approaches to maximize ethical behavior and to avoid the dangers of individual and institutional isolation. Covered topics shall include communication with family members and other professionals, the risks of dual relationships with clients and personal multiple relationships with other licensed mental health professionals, identifying and avoiding inappropriate talk about the therapist's personal life, actions and documentation during ethical dilemma situations and boundary crossings, the vital need for regular colleague consultation, and communication with the Board of Mental Health Practice.

Learning Objectives

- Participants will understand current legal and ethical issues that affect their mental health practice.
- Participants will be exposed to thorough and ethical documentation practices, particularly as influenced by insurance requirements.
- Participants will be able to identify ethical considerations in case formulation.
- Participants will be able to identify and implement several DOs and DON'Ts of structuring therapy so as to engage in ethical practice, effectively manage ethical dilemmas, and minimize the risk of complaints of alleged misconduct to the NH Board of Mental Health Practice.
